| Scholarship Yojana | Under Saraswati Karkirdi Yojana, top 5 students securing 90% or more marks in 10 & 12 standard (each) are honored with Rs. 5,000/- (Rs. Five Thousand) as token of appreciation for their efforts and achievement. Students to apply under Saraswati Scholarship Yojana should send (a) Application letter with their Name, Address and Photo (b) Copy of Mark Sheet. |
| <u>Higher Education Yojana</u> | |
| Criteria | Students who have passed 10 standard and pursuing further (higher) studies. |
| Income Eligibility | Students, whose family yearly income is Rs. 2,25,000/- or less, can apply under this Yojana |
| Aid Amount | 1) 1) 50% of Fees or Rs. 25,000/- whichever is less. 2) 2) Fees of Rs. 5,000/- or less will get 100% fees. |
| <u>Coaching Classes / Vocational Training Yojana</u> | |
| Criteria | Following Students can apply under Coaching Classes / Vocational Training Yojana. 1) For Coaching Classes - Students of Standard 8th to 15th. 1. Students enrolling for Coaching Classes of any Post Graduate or Double Graduate Courses including classes joined for Entrance Exam of Post Graduate Course. 2) Under Vocational Training Yojana, any person doing classes like Mehndi, Computer, Beauty Parlor etc. for their livelihood can also apply. |
| Income Eligibility | Students / Person whose family Yearly Income is Rs. 2,25,000/- or less can apply under this Yojana. |
| Aid Amount | Aid Amount 50% of Fees or Rs. 15,000/- whichever is less. |
| Instructions | 1) Financial benefit will be denied to any such student / applicant who have a car (4 wheeler) in his family. 2) Student / Parents applying under Saraswati Karkirdi Yojana should be Member of SNVVS. 3) Separate form should be filled for each student. (Collect from office or to fill up the xerox form.) 4) Enclose clear xerox copy of Mark Sheet and Receipt of Paid Fees. Bring Original Copies to check. 5) Under Saraswati Karkirdi Yojana one student can get Maximum of Rs. 30,000/- Fees only. 6) Form should be complete in all respect along with Bank details. Amount will be directly remitted to account details provided by the applicant. |
| Important Instructions : | 1) Smt. Shardaben Navnitlal Shah Trust (Pune) will give additional Rs. 10,000/- to students whose fees is Rs. 1 Lakh & above under SKY. Maximum overall contribution for this additional amount is Rs. 1 Lakh. So if there are more than 10 students with fees of Rs. 1 Lakh, then amount of Rs 1 Lakh will be pro-rata distributed among eligible students. 2) Shree Vallabh Charitable Trust (Mumbai) will pay additional Rs. 25,000 to student who is doing post-graduate course. Maximum overall contribution for this additional amount is Rs. 1 Lakh. So if there are more than 4 students applying for post graduate fees, then amount will be pro-rata distributed among eligible students. |
